### National Women's History Project

The NWHF, founded in 1980, is an educational nonprofit organization. Its mission is to recognize and celebrate the diverse and historic accomplishments of women by providing information and educational materials and programs. One of the 2014 NWHF Honorees is **Jaida Im, Advocate for Survivors of Human Trafficking**. Under her direction, the program offers holistic case management, counseling, educational resources, and job training for victims of abduction and enslavement. In fall 2013, Freedom House opened The Nest to serve girls ages 12-17. This new shelter provides a space to help girls to recapture their interrupted youth in a loving family setting. 

# Campaign Against Pornography Continues

*Morality in Media* has published its 2014 'Dirty Dozen' List. Why such a list? Common sense, anecdotal evidence and scientific research all demonstrate that pornography is a harmful, mind-altering drug. Our nation is suffering a pandemic of harm from pornography. Consequences include:

- Children and adults developing life-long addictions to pornography;
- On average, American children are seeing hardcore pornography at age 11 and often acting out what they see in porn;
- Four out of five 16-year-olds now regularly access pornography online and many are developing life-long social/sexual problems as a result;
- Violence against women, rape and other sex crimes are directly tied to the consumption of pornography;
- 56% of divorces cite Internet pornography as a factor in the breakup;
- There is increased demand for child pornography because many adult-porn users find they are no longer excited by adult images and move to child images;
- Pornography is a major factor creating and driving demand for prostituted and trafficked women and children;
- More and more young men are suffering from sexual dysfunction as a result from repeated and prolonged porn use.

In addition to the many proven harms of pornography, it is a violation of federal law to distribute obscene (hardcore adult pornography) material on the Internet, cable/satellite TV, hotel/motel TV, in retail shops, through the U.S. Mail, and by common carrier. Additionally, most states prohibit the distribution of obscene pornography. Despite pornography's destructive force and the illegality of most pornography in the US, its availability is increasing.



### Victories from the 2013 'Dirty Dozen List':

- The **Department of Defense** stopped the sale of pornography in the Army and Air Force exchanges and all branches removed explicit content from public and work spaces;
  - **Comcast** improved their parental settings for cable;
  - **Facebook** took steps to improve efforts to block child pornography on its site;
  - **GooglePlay** instituted policies that prohibit allowing pornographic apps in their app store (these need enforcement though).
- Morality in Media* asks consumers and citizens to publicly recognize the 2014 'Dirty Dozen' as responsible parties in the spread of pornography and exploitation. Take action to promote change.

### Attorney General Eric Holder

Mr. Holder refuses to enforce existing federal obscenity laws against hardcore adult pornography, despite the fact that these laws have been upheld by the U.S. Supreme Court and effectively enforced by previous attorneys general.

**Verizon** pushes porn into our homes through multiple channels. Not only do they provide hardcore pay-per-view movies through *Fios*, but they are also in the distribution business through *Verizon* smartphones, tablets

and as an Internet Service Provider. *Verizon* could filter and block such content. They provide few options for those who do not want this material.

**Facebook** The world's most popular social networking site has become a top place to trade pornography, child pornography and for sexual exploitation. *Facebook's* guidelines prohibit such behavior, but *Facebook* is doing little to enforce them.

**Google** *Google's* empire thrives on porn. Porn is shoved at kids today through *YouTube*, *GooglePlay*, *Google Images* and *Google Ads*. We urge *Google* to continue to improve their efforts to protect children and all who wish to be porn-free.

**Sex Week** Many of our nation's top schools are succumbing to student pressure to welcome "sex week"

celebrations that include hardcore pornography, as well as pornographic displays for public consumption on campuses. Some schools have included lectures on sex by naked instructors and demonstrations encouraging students to engage in violent, torture sex. Yale University was the first to initiate *Sex Week*.

**Hilton** This hotel chain, like *Hyatt*, *Starwood* and many other top hotel chains, provides hardcore pornography movie choices; and its porn channels are often the first thing advertised when you turn on the TV.

**Tumblr.** One can hardly go on this popular social media blogging site without being bombarded with porn. Users must only be 13 and the filters do not work.

#### **American Library Association**

For years, the ALA has worked to encourage public libraries to keep computers unfiltered and allow patrons, including children, access to pornography.

The **PlayStation 4** is the most popular game console used today, with over 4.2 million sales in 2013. Children under 18 are their main users. *PlayStation's* livestreaming abilities are filling thousands of homes with live porn and hundreds of pornographic and sexually violent games are in the *PlayStation Store*.

**Cosmopolitan** This staple of the supermarket checkout line may be as pornographic as *Playboy Magazine*, but without the pictures. This publication has steadily declined from an inspirational women's magazine into a full-on pornographic "how-to" sex guide, encouraging women to accept the pornified culture around them.

What's worse is that they specifically market their smut to teen girls.

**Barnes&Noble** This Fortune 500 company, operator of 689 retail bookstores and a very active website, is a major supplier of adult pornography and child erotica. They also regularly put pornography near the children's sections in their stores and provide free, unfiltered porn publications on their Nook e-reader.

**Fifty Shades of Grey** The best-selling book and future movie are normalizing rape and sexual torture of women. *Oprah Winfrey Network*, *Broadway* and other mainstream outlets have promoted this abusive lifestyle.

#### **MIM Updates:**

- *Google* asked to meet in April 2014 with *Morality in Media (MIM)* to discuss ways that will get *Google* off the *Dirty Dozen* list.
- An investor shifted \$500,000 from *Verizon* to another company after learning that *Verizon* rents child-themed porn on *Fios TV*.
- A former pimp/pornographer in Uganda has turned to helping survivors after following *Morality in Media* efforts.
- In February 10,595 efforts were taken to oppose porn and exploitation by readers of *Morality in Media*.



### Porn T-Shirts

Judy Cox of Orem, Utah, was shopping at the mall with her son when she was affronted by T-shirts she considered to be indecent and "pornographic." To solve the problem, she bought all of the shirts for \$567.

The shirts are a part of the "Visual" line of clothing currently being sold at *PacSun*. Cox complained to the store manager, who reported it to her district manager.

Cox also expressed her outrage to the mall manager, who said that she was not alone in her complaints. Cox has met with the city attorney, but the process of deciding whether or not the store is breaking any laws could take weeks.

Cox says she is going to eventually return the shirts and will let the retailer's corporate office "figure out what to do with them when I return them on day 59 of a 60-day return policy."

*PacSun* CEO Gary Schoenfeld said in a statement, "The company takes pride in the clothes and products it sells... While customer feedback is important to us, we remain committed to the selection of brands and apparel available in our stores." ### The 4th Annual Norma Hotaling Anti-Trafficking Awardees

To commemorate Norma Hotaling's death in 2008, the Global Centurion Foundation (GCF) pays tribute to Norma's legacy by recognizing individuals continuing her work. GCF, founded by Laura Lederer, is a non-profit organization fighting trafficking by focusing on demand.

#### **Survivor-Centered Service Provider Award: Kathleen Mitchell, Founder, DIGNITY House**

Kathleen embodies the spirit of resilience and hope for which Norma Hotaling stood.



Growing up in conditions of extreme abuse and neglect, Kathleen met a man who told her she would never again have to live like that. These promises quickly became a nightmare as he forced her into prostitution and kept her there through physical and emotional abuse, taking every penny she earned. She was sent to prison for prostitution and pimping, and while there started DIGNITY House ("Developing Individual Growth and New Independence Through Yourself") in 1989. Her first act was to lobby for special programs for sex trafficking victims in jail. Upon her release she helped trafficked women regain a sense of their own dignity. Since its inception in a Durango jail, it has expanded to include a series of life-saving programs, including a residential program for victims; an intensive recovery program of counseling, addiction recovery, education, life-skills building and job placement; a self-exploration program in conjunc-

tion with the City of Phoenix Prosecutor's Office; an outreach program; and public events to raise awareness and generate greater public support in a wider effort to end sex trafficking. An early pioneer, Kathleen Mitchell established networks that serve as a model for providing material, emotional, and spiritual aid to victims of sex trafficking. Her decades of work are an example of how suffering can be transformed to hope and help for others.

#### **Josephine Butler Abolitionist Award for Law and Policy Development: James Dold, Former Senior Policy Counsel, Polaris Project**

Both in his personal life and in his work, James has been a fierce anti-trafficking advocate. Over the course of the last three years, James led efforts to pass 40 laws across 18 states that provided prosecutors the tools they need to protect victims of sex and labor trafficking, more effectively target traffickers and "johns," and help victims of human trafficking rebuild their lives. Whether using his legal skills to draft legislation, or advocating the creation of bi-partisan legislative task forces and coalitions to advance new anti-trafficking laws, or



working with local NGOs to address specific state and local trafficking issues, James' contributions have been substantive and lasting. They include laws that: criminalize labor and sex trafficking; provide mechanisms for seizing the assets of traffickers, pimps, and johns; establish state-wide anti-trafficking task forces; mandate posting of the National Human Trafficking Resource Center hotline in places where victims may see them; enact legal reforms that enable prosecutors to more successfully punish wrongdoers; aid victims in suing their abusers; help survivors vacate or expunge criminal records; and protect trafficked or exploited children from being charged or prosecuted as criminals, diverting them instead into services they need and deserve. James is a champion of systemic change to punish perpetrators and protect victims.

#### **Innovative Demand Reduction Award: Melissa Farley, Founder, Prostitution Research & Education**

Melissa Farley Ph.D. has been a practicing clinical psychologist for 45 years. She has written 24 peer-reviewed articles on sex trafficking. In 2011, Dr. Farley co-authored the first study comparing sex buyers to non-

### Amsterdam to Raise Legal Age for Women in Prostitution

Amsterdam plans to raise the minimum age for prostitutes from 18 to 21 and force brothels to close during early morning hours.

At a press conference, Amsterdam's mayor said the moves came from a decision to crack down on crime in the city's famed Red Light District and protect sex workers — mostly women — from abuse.

Amsterdam is home to about 8,000 professional sex workers. The city estimates half of them operate behind windows with red velvet curtains and red lights. The mayor said under the new regime, all windows would be closed from 4 a.m. to 9 a.m. The city intends to introduce the new measures by July. "We think the situation is so grave that we have to act," the mayor told reporters.

He said young prostitutes were particularly vulnerable because they were often groomed by pimps who force them into service when they turn 18. He said the city's first priority was to keep women from being pushed into prostitution and the second priority was to help those who wish to exit the profession. Other measures he plans to introduce include forcing all brothel owners to submit a business plan.

Prostitution was legalized in the Netherlands in 2000. It has been tolerated in Amsterdam since the 1600's, when the spice trade made it one of the world's wealthiest port cities. But the city has been tightening its rules since 2006 and shuttered a third of its brothel windows from 2007 to 2009.

The Dutch tolerance of prostitution has always been a subject of debate, and after it was legalized, city officials realized that move had not served to reduce abuses. A proposed new national law would create a database of registered prostitutes, but it has never been passed by Parliament.

Dutch officials are now studying Sweden's prostitution laws as a possible model. Swedish law criminalizes only those who visit prostitutes and does not punish the prostitutes themselves.

### Speaking Up Against Pornography

In January 2014 Canadians, including the Congregation of Notre Dame Sisters and their CND Associates, sent letters to the mayor of Montreal to applaud his willingness to 'crack down on erotic massage parlors.' Citizens of other localities did the same in order to raise the awareness and ask support of Canadian city leaders to the growing problem of trafficking, the exploitation of women and the dangers of pornography, especially among the young.

In early February, letters were sent to the editors of newspapers that publish ads which degrade the dignity of women, such as pages where 'certain types' of classified ads describe "exotic, erotic experiences" or "beautiful, oriental, gorgeous girls". Newspaper pages displaying the offensive ads were enclosed with the letter to show both the readership and the protest.

sex buyers. Her findings show that compared to non-sex buyers, sex buyers shared



certain attitudes, life experiences, and behavioral tendencies that increase the likelihood of future violence against women. She also examined various deterrence efforts, and found that being listed in sex offender registries, having arrest records published in local newspapers, and serving jail-time were the most effective deterrents for sex buyers.

Her findings strengthen the proposition that state and federal laws against sex trafficking should be enforced against johns. In addition, the study supports the idea that education programs aimed at sex buyers should be implemented subsequent to sentencing, not in lieu of it.

Dr. Farley founded Prostitution Research & Education (PRE) in 1995, a nonprofit organization dedicated to research, education, and policy on commercial sexual exploitation and its impact on women, men, and children. She has consulted with several cities in the U.S. as they craft new policies to deal with increasing evidence that violence is at the heart of sex trafficking, and as cities confront men's demand for commercial sex which creates and expands trafficking.

#### *Tricked*

Modern-day slavery is alive and well in the United States as thousands of victims are trafficked throughout the country to satisfy America's \$3 billion a year sex trafficking industry. Meet the pimps, the johns, the police, the parents and the victims of the America's thriving sex trade in *'Tricked'*, a comprehensive documentary that uncovers America's dirty secret. It's an industry that is fueled by greed, fantasy and the commercial sexual exploitation of American children and girls.

Embedded with the Denver Vice squad, *'Tricked'* follows Sgt. Dan Steele and his colleagues in their dogged pursuit of traffickers and devotion to rescuing victims. In Las Vegas, ground zero for escort services, Las Vegas Police detectives work to hit traffickers where it hurts them most, by seizing their financial assets. In New York, Chicago and Las Vegas, brash and unrepentant johns reveal the how, why, when and where of what they call "a hobby."

From Sgt. Steele to the survivors, *'Tricked'* weaves together dramatic, disparate, inter-dependent characters and provides an unflinching view of the world of sex trafficking, the almost incomprehensible and disturbing bonds between the traffickers and victims and the seemingly insurmountable challenges faced by law enforcement nationwide. *'Tricked'* premiered on December 13, 2013 in New York City. #### *'Tales from the Organ Trade'*

The documentary explores the controversial practice of black-market organ trafficking: from the street-level brokers who solicit kidney donors, to the rogue surgeons who perform the operations; from the impoverished donors willing to sacrifice a part of their bodies for a quick payday, to the desperate patients who face the agonizing choice of obeying the law or saving their lives. With unprecedented access to all the players, this 83-minute documentary explores the legal, moral and ethical issues involved in this complex life-and-death drama. More than a simple black-and-white story of exploitation, *'Tales from the Organ Trade'* is a nuanced and complex film that challenges moral and ethical beliefs. It delves into a world where "villains" often save lives and the medical establishment, helpless to its own rules and bureaucracy, too often watches people die. In the best scenario, victims walk away content and safe, and buyers of organs (the recipients) return home with a new lease on life. From Manila to Istanbul, Colorado to Kosovo, Toronto to Tel Aviv, this film spotlights a compelling cast whom fate has brought together, where the gift of life meets the shadow of death.

### June 4-6, 2014 Course on Human Trafficking: Laws, Data, Discourses, and Practices

The Institute for the Study of International Migration (ISIM) at Georgetown Univ. in Washington D.C. offers this three-day course with Prof. Elzbieta M. Gozdzik as the lead lecturer.

#### Course description

The subject of human trafficking, or the use of force, fraud or coercion to transport persons across international borders or within countries to exploit them for labor or sex, has received renewed attention within the last two decades. In the U.S. human trafficking became a focus of activities in the late 1990s and culminated in the passage of the Trafficking Victims Protection Act (TVPA) signed into law on October 16, 2000.

In this course students will assess the different legal frameworks used to combat human trafficking around the world and compare the different discourses used to discuss the trafficking phenomena in North America and in Europe. Students will also explore the characteristics and special needs of victims (adult and child victims, girls and boys, women and men), their life experiences, and their trafficking trajectories; discuss the methods of traffickers and their networks; debate the effectiveness of governmental anti-trafficking policies and the efficacy of rescue and restore programs; and identify research gaps. The course places special emphasis on evidence-based research and strategies. An interdisciplinary team of legal and social science scholars, policy-makers, and practitioners teach this course, which is offered as part of a Certificate in International Migration Studies and can be taken as a free-standing course or in conjunction with other courses in the certificate.
